#### B. ADDITIONS TO THE SCOPE OF WORK:

The following additions are made to the scope of work.

#### East Lake Clubhouse:

- Painting the outside of the buildings should include pressure washing.
- The Main Building kitchen cabinetry should be removed, kept, and put back after the exterior wall work is complete.
- PCHA will handle the asbestos removal behind the existing mirrors in the main building and gym.
- Gym ceiling to be skimmed, retextured and painted.
- The Gym Floor Specifications attached.

#### East Lake Clubhouse Garage Unit #8:

- Per the plans, all exterior walls of the 4-bay Garage Building are in the scope.
- All bidders should add a 10% contingency for unforeseen circumstances with sheathing, studs and connectors needing replacement behind the walls.
